1 Respective responsibilities of the body and the auditor

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- Information received from the smaller authority indicates that £321 of expenses, including a lockable cabinet, have been included in the figure in Section 2, Box 4 for the current year. Please note that Box 4 should comprise all payments made in relation to the employment of staff including only employment expenses which are benefits (mileage, travel, etc.) but not items of reimbursement of expenses for postage, stationery or other outlays made on behalf of the smaller authority. Section 2, Boxes 4 and 6 for the current year should read £10,669 and £28,171 respectively.
